This is the first year that we were able to carry out two trips to Cameroon. Each was designed to support hospitals, deliver access to drugs and advance collaborations with potential drug producers, investors, the Prime Minister, Minister of Public Health and the US Embassy Department of Business Development. In addition to the ongoing Miconazole project, the delivery medical supplies and children's multi vitamin and aspirin, a second revolving drug fund has been established in the village of Esu. This activity fulfills our tax exempt purpose of delivering access to medicine.

Form 990-EZ, Part III, Line 29 - Statement of Program Service Accomplishments

AIDSfreeAFRICA "adopts" Esu, a village of 30,000 to 40,000 people in a rural region most affected by HIV/AIDS. For the first time the organization organized AIDS testing and counseling. People infected with HIV met and founded the Esu Family Health Association. The Youth of the village also organized under our leadership and guidance. Dr. Hodel met with all important groups of Esu for strategic meetings and to plan future projects that are self-sustainable, income generating and centered around AIDS and drug access.

Fundraising, PR and volunteers: AIDSfreeAFRICA maintains web site, Facebook site and blog. AIDSfreeAFRICA president is a national tour speaker.
